**PUBLIC HEALTH (COVID-19 CONTROL AND SUPPRESSION) (AMENDMENT) ORDER**

**THE PUBLIC HEALTH (COVID-19 CONTROL AND SUPPRESSION) (AMENDMENT) ORDER 2020 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 10 OF THE PUBLIC HEALTH ACT (CAP. 14.01).**

**1. Citation**

This Order may be cited as the Public Health (Covid-19 Control and Suppression) (Amendment) Order, 2020.

**2. Interpretation**

In this Order “**principal Order**” means the Public Health (COVID-19 Control and Suppression) Order, 2020.

**3. Paragraph 2 amended**

Paragraph 2 of the principal Order is amended:

- (a) in the definition of “essential service” at subparagraph (n) by deleting “or”;
- (b) by inserting the following after “ferry services;”—
  - “(p) services of a bakery;
  - (q) services connected with fisheries;
  - (r) a food delivery service, by a person or business that is granted permission to operate as a food delivery service under paragraph 5(7); or
  - (s) a service deemed to be an essential service under paragraph 5(8); and”;and
- (c) by inserting the following definition in the correct alphabetical sequence—

““**Minister**” means the Minister responsible for health matters;”

**4. Paragraph 5 amended**

Paragraph 5 of the principal Order is amended by inserting, immediately after subparagraph (6), the following subparagraphs—

“(7) Despite subparagraph (1) the Minister may, in exceptional circumstances, give a person written permission to—

(a) be in a public place later than 7 pm daily and before 5 am the following day; or

(b) operate as a food delivery service provider.

(8) The Minister may, in writing, deem a service to be an essential service.”
