1. Citation

This Order may be cited as the Road Traffic (Race and Speed Trial) (Designation of Place) (Amendment) Order, 2019.

2. Interpretation

In this Order, “**principal Order**” means the Road Traffic (Race and Speed Trial) (Designation of Place) Order, 2018 (S.R.O. 42 of 2018).
