**THE ROAD TRAFFIC (AMENDMENT) REGULATIONS 2019 MADE  
BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET  
UNDER SECTION 7 OF THE ROAD TRAFFIC ACT (CAP. 7.06)**

**1. Citation**

This Order may be cited as the Road Traffic (Fees) Order, 2019.

**2. Interpretation**

In this Order, “**the Act**” means the Road Traffic Act (Cap. 7.06).

**3. First Schedule replaced**

The First Schedule to the Act is deleted and the following is substituted—
