THE PUBLIC HEALTH (COVID-19 SUPPRESSION) (NO. 11) (AMENDMENT)
ORDER 2022 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET
UNDER SECTION 10 OF THE PUBLIC HEALTH ACT (CAP. 14.01).

1. Citation and commencement

This Order may be cited as the Public Health (Covid-19 Suppression) (No. 11) (Amendment) Order, 2022 and comes into force 1 January, 2022 at 6 p.m.

2. Interpretation

In this Order “principal Order” means the Public Health (COVID-19 Suppression) (No.11) Order, 2021.

2. Paragraph 2 amended

Paragraph 4(1) of the principal Order is deleting the definition of “**large gathering**” and substituting the following—

“**large gathering**” means a gathering of more than fifteen persons;

3. Paragraph 3 amended

Paragraph 3(3) of the principal Order is deleted and the following is substituted—

“(3) The prohibition under subparagraph (2) does not apply to a large gathering—

(a) at a customs airport and a customs port if the purpose of the large gathering is for the embarkation or disembarkation of passengers; or

(b) at a sitting of the High Court.
