PUBLIC HEALTH (COVID-19 SUPPRESSION) (NO. 11) (AMENDMENT) ORDER

THE PUBLIC HEALTH (COVID-19 SUPPRESSION) (NO. 11) (AMENDMENT) ORDER 2022 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 10 OF THE PUBLIC HEALTH ACT (CAP. 14.01).

#### 1. Citation and commencement

This Order may be cited as the Public Health (Covid-19 Suppression) (No. 11) (Amendment) Order, 2022 and comes into force 1 January, 2022 at 6 p.m.

#### 2. Interpretation

In this Order "principal Order" means the Public Health (COVID-19 Suppression) (No.11) Order, 2021.

#### 2. Paragraph 2 amended

Paragraph 4(1) of the principal Order is deleting the definition of "large gathering" and substituting the following—

"large gathering" means a gathering of more than fifteen persons;

#### 3. Paragraph 3 amended

Paragraph 3(3) of the principal Order is deleted and the following is substituted—

- "(3) The prohibition under subparagraph (2) does not apply to a large gathering—
  - (a) at a customs airport and a customs port if the purpose of the large gathering is for the embarkation or disembarkation of passengers; or
  - (b) at a sitting of the High Court.
