3. The Introduction and First Reading of the following Bill took place:

## **Securities Bill 2021**

First Reading 30 November 2021

The Bill seeks to provide protection for investors in securities and for those within the currency union. It provides regulation for the securities market, exchanges and persons in the securities business. Part II of the Bill provides for licensing of marketplaces and ancillary facilities, Part III provides for licensing of intermediaries and individuals, Part IV provides for conduct of business by licensees, Part V provides for registration and distributions of securities, Part VI provides for continuing obligations of reporting issuers, Part VII provides for governance of reporting issuers. Part VIII of the Bill provides for takeover bids, Part IX provides for disclosure of shareholdings of Directors, Officers and significant security holders, Part X provides for uncertificated securities, Part XI provides for market misconduct, Part XII - listing and trading foreign securities licensing and exchange membership of foreign market participants Part XIII provides for investigations, inspections, enforcement, Part XIV provides for civil liability for misrepresentation, and Part XV makes miscellaneous provisions.
