

SUMMARY REPORT PROCEEDINGS OF THE LEGISLATIVE ASSEMBLY HELD ON 30th May 2023

'Revenue Laws (Consequential Amendments) Bill 2023'

'Tax Administration Bill 2022'

5. The following Bill had its Introduction, First, Second, and Third Reading:

'Supplementary Appropriation (2023) Bill 2023'

First Reading 30th May 2023 Second Reading 30th May 2023 Third Reading 30th May 2023

The Bill sought to sanction certain payments from the Consolidated Fund in excess of the sums provided by law for the services of the Government of Montserrat for the period ending on the thirty-first day of March 2024.

6. The following Bill was introduced and had its first reading:

'Elections (Amendment) Bill 2023'

First Reading 30th May 2023

The Bill seeks to amend the Elections Act Cap 1.04:

Clause 1 sets out the short title of the Bill.

Clause 2 of the Bill defines the term "principal Act".

Clause 3 of the Bill inserts definitions for terms used in the Bill.

Clause 4 of the Bill amends section 4 of the Act by providing for the appointment of a Supervisor of Elections by the Governor acting on the recommendations of the Electoral Commission.

Clause 5 of the Bill inserts a new section 9A into the Act which provides for the appointment of fit and proper persons to be assistant returning officers and sets out the functions of an assistant returning officer.

Clause 6 of the Bill amends section 12 of the Act by providing that an unconvicted prisoner is entitled to be registered as a voter, to remain on the electoral register and to vote at a general election or by-election.

Clause 7 of the Bill inserts a new section 27A into the Act which provides for the establishment of mobile polling stations at His Majesty's Prison, a hospital or any other a residential care home or facility. Clause 7 also sets out the functions of the returning officer with respect to a mobile polling station.

Clause 8 amends section 56 of the Act by providing for the certification and publication of election data. Election data include data disaggregated by:

- (i) number of names on the list of voters;
- (ii) polling stations;
- (iii) the names of the candidates who received the largest number of votes to be elected to be members of the Legislative Assembly;
- (iv) the number of votes polled for each candidate; and the number of ballots issued, spoiled, or rejected.
