i. 'Terrorism, Terrorist Financing and Proliferation (Sanctions) Bill 2024'

The Bill seeks to provide for the implementation of targeted financial sanctions related to terrorism, terrorist financing, and proliferation.

ii. 'Legislative Assembly (Powers, Privileges and Immunities) Bill 2024'

The Bill seeks to declare and define certain powers, privileges, and immunities of the legislative assembly and to give protection to the persons employed in the publication of the reports and other papers of the assembly and for purposes incidental to or connected with the matters aforesaid.

iii. 'Cemeteries Bill 2024'

The Bill seeks to repeal the Burial Grounds Act (Cap. 14.12) and to regulate the interment of deceased persons and related matters.
