The Bill provides for the following areas: Part Two - Purpose and Application, Part 3—Administrative Structure for Public Procurement, Part 4—General Provisions, Part 5—Award of Public Contracts, Part 6—Award of Public Contracts Part 7—Sustainable Procurement, Part 8—Transparency and Integrity, Part 9—Challenge Procedures and Part 10—Miscellaneous
