THE ELECTION (CONTINUOUS REGISTRATION) (AMENDMENT OF SCHEDULE) REGULATION 2023 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 15(4) OF THE ELECTIONS ACT (CAP. 1.04).

1. Citation

This Order may be cited as the Election (Continuous Registration) (Amendment of Schedule) Regulations 2023.

2. Schedule amended

The Schedule of the Election (Continuous Registration) Regulations (Cap. 1.04) is amended by deleting Form 1 and substituting the following—
