(DION BRAMBLE) (EXEMPTION) ORDER

THE CUSTOMS DUTIES AND CONSUMPTION TAX (DION BRAMBLE) (EXEMPTION) ORDER 2024 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Dion Bramble) (Exemption) Order, 2024.

2. Exemption

Subject to paragraph 3, Dion Bramble is exempted from the payment of Consumption Tax on the importation of the items described in the Schedule.

3. Conditions

The exemption referred to in paragraph 2 only applies if the items are—

- (a) imported by and addressed to Dion Bramble; and
- (b) used by Dion Bramble on his property located at Block 12/4 Parcel 456.

4. Record keeping

- (1) Dion Bramble shall keep a record of the items imported pursuant to paragraph 2 and shall produce the record to the Comptroller of

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Dion Bramble) (Exemption) Order, 2024.

2. Exemption

Subject to paragraph 3, Dion Bramble is exempted from the payment of Consumption Tax on the importation of the items described in the Schedule.

3. Conditions

The exemption referred to in paragraph 2 only applies if the items are—




