Police (Amendment) Bill No. 4 of 2025

First Reading: 24th June 2025

The purpose of the Bill is to seek to amend the Police Act (Cap. 10.01) (“the Act”)

Public Procurement Bill 2025, No 5 of 2025

First Reading: 24th June 2025

The purpose of the Bill is to update and modernize the law relating to the procurement of goods, works, and services by ministries, departments, units, any subdivision of the Government, and Government-owned entities.

The following bill had its second and third readings:

Seventh Day Adventist Church Incorporation (Amendment) Bill 2025

First Reading: 10th April 2025

Second Reading: 24th June 2025

Third Reading: 24th June 2025

The purpose of the Bill was to seek to amend the Seventh-day Adventist Church Incorporation Act (Cap. 294) (“the Act”)

The Bill was passed and can be obtained from the Legislature Department.

5. A Resolution was brought to the Montserrat Legislative Assembly on Tuesday, 24th June, 2025 by the Honourable Donaldson Romeo for consideration of an increase in support to the income and salaries of the Vulnerable, the Working Poor, Pensioners, Public Servants, and other affected persons in the Public and Private Sector.

The resolution was not carried.
