CHILD JUSTICE COMMITTEE (TERM OF OFFICE) REGULATIONS

THE CHILD JUSTICE COMMITTEE (TERM OF OFFICE) REGULATIONS 2025 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTIONS 81 OF THE CHILD JUSTICE ACT (No. 25 OF 2024).

1. Citation

These Regulations may be cited as the Child Justice Committee (Term of Office) Regulations, 2025.

2. Term of appointment

The Governor acting on the advice of Cabinet may appoint a member of the Child Justice Committee for a period not exceeding three years and the member is eligible for reappointment on the expiration of his appointment.

3. Resignation of members of the Child Justice Committee

- (1) A member of the Child Justice Committee, other than the Chairperson may at any time resign his membership by letter addressed to the Governor and transmitted through the Chairperson, and the members ceases to be a member of the Child Justice Committee from the date of receipt of the letter by the Governor.
- (2) The Chairperson may at any time resign as a member of the Child Justice Committee by letter addressed to the Governor and the resignation shall take effect after a period of one month from the date of the receipt of the letter by the Governor, if no response is given earlier by the Governor.
- (3) Where a member of the Child Justice Committee resigns or is unable to carry out the functions of his office, the Governor acting on the advice of Cabinet may appoint a new member, in accordance with section 6(2) or (3) of the Child Justice Act.

4. Remuneration

For each sitting of the Child Justice Committee, the members shall each be paid \$250.
