**A BILL FOR**

AN ACT TO AMEND THE POLICE ACT (CAP. 10.01.)

BE IT ENACTED by The King’s Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Montserrat, and by the authority of the same as follows:—

**1 Short title**

This Act may be cited as the Police (Amendment) Act, 2025.

**2 Interpretation**

In this Act—

“**principal Act**” means the Police Act (Cap. 10.01).

**3 Section 35 deleted**

Section 35 of the principal Act is deleted and substituted by the following—

“The hearing and determination of a charge or complaint shall be in accordance with Regulations made under section 54 of this Act.”.

**4 Section 36 deleted**

Section 36 of the principal Act is deleted and substituted by the following—

“An appeal under this Act and Regulations shall be in accordance with Regulations made under section 54 of this Act.”.

**5 Section 37 deleted**

Section 37 of the principal Act is deleted.

**6 Section 38 amended**

Section 38(b) of the principal Act is amended deleting “section 35(1)” and substituting “regulations made under this Act.”.

**7 Section 39 deleted**

Section 39 of the principal Act is deleted and substituted by the following—

“Payment during suspension and related matters shall be in accordance with Regulations made under section 54 of this Act.”.

**8 Section 54 amended**

Section 54(1) of the principal Act is amended by inserting the following as (ca) –

“(ca) the conduct and performance of members of the Service to include hearing and determination of a charge or complaint, suspension and related matters;”.
