



**SUMMARY REPORT NO. 10**  
**OF THE PROCEEDINGS OF THE**  
**18<sup>th</sup> PARLIAMENT OF THE MONTERRAT LEGISLATIVE ASSEMBLY**  
**HELD 30<sup>th</sup> September 2025**

1. The Parliamentary Year begun with a with a ceremonial parade followed by the procession of Honourable Members of the Legislative Assembly into the House. The Sitting was briefly suspended to allow presentations to be made by the Primary Schools.
