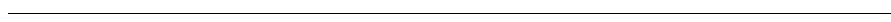

THE CONSUMPTION TAX (ROOSEVELT JEMMOTTE) (EXEMPTION) ORDER 2025 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Consumption Tax (Roosevelt Jemmotte) (Exemption) Order, 2025.

2. Exemption

Roosevelt Jemmotte trading as I.D Montserrat, is exempted from the payment of Consumption Tax on the importation of the items set out in the Schedule.

3. Expiration

This Order expires on 19 November, 2026.
