# **M O N T S E R R A T**

**No. 11 of 2019**

**AN ACT TO SANCTION CERTAIN PAYMENTS FROM THE CONSOLIDATED FUND IN EXCESS OF THE SUMS PROVIDED BY LAW FOR THE SERVICES OF THE GOVERNMENT OF MONTSERRAT FOR THE PERIOD ENDING ON THE THIRTY-FIRST DAY OF MARCH, 2020.**

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Montserrat, and by the Authority of the same as follows:—

**1      Short title**

This Act may be cited as the Supplementary Appropriation (No. 4) Act, 2019.

**2      Authorisation of expenditure**

The sum of One hundred and Thirty-nine Million, Seven Hundred and Seventy-two Thousand, Two Hundred dollars (\$139,772,200) that was authorised to be issued from the Consolidated Fund by the Appropriation Act (No. 3 of 2019) and the Supplementary Appropriation Act (No. 9 of 2019), is to be expended as set out in the Schedule.

**3      Payments**

The Accountant General is authorised and required from time to time, upon the authority of warrants issued under the hand of the Minister of Finance, to pay the sums set out in the Schedule to the several services mentioned as the warrants may direct out of the Consolidated Fund without further order or formality.
