**THE CUSTOMS DUTIES AND CONSUMPTION TAX (SPENCE POP PLUS) (EXEMPTION) ORDER 2021 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP.17.05).**

**1. Citation**

This Order may be cited as the Customs Duties and Consumption Tax (Spence Pop Plus) (Exemption) Order, 2021.

**2. Exemption**

Samuel Spencer, trading as Spence Pop Plus is exempted from the payment of Customs Duty and Consumption Tax on the importation of the items set out in the Schedule.

**3. Repeal**

The Customs Duties and Consumption Tax (Spence Pop Plus) (Exemption) Order (SRO No. 20 of 2019) is repealed.

**4. Expiry**

This Order expires one year after publication.
