PUBLIC HOSPITAL (AMENDMENT) (NO. 3) REGULATIONS

THE PUBLIC HOSPITAL (AMENDMENT) (NO. 3) REGULATIONS 2021 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 8(x) OF THE PUBLIC HEALTH ACT (CAP. 14.01).

1. Citation

These Regulations may be cited as the Public Hospital (Amendment) (No. 3) Regulations, 2021.

2. Schedule of Fees amended

The Schedule of Fees in the Public Hospital Regulations (Cap. 14.01) is amended by deleting item 1 and 2 of Part 3 and substituting the following—

- 1.** “The fee payable for a PCR COVID-19 test or a RNA COVID-19 test is as follows:

<i>(a)</i>	If the test is being taken within 24 hours of entry into Montserrat by a person who is not fully vaccinated.....	\$300
<i>(b)</i>	If the test is being taken 5 days after entry into Montserrat by a non- resident technician who is not fully vaccinated	\$300
<i>(c)</i>	If the test is being taken between 3 to 4 days after entry into Montserrat by a fully vaccinated person, to include a non-resident technician who is fully vaccinated	\$150
<i>(d)</i>	If the test is being taken between 10 to 12 days after entry into Montserrat by a person who is

	not fully vaccinated, to include a non-resident technician who is not fully vaccinated.....	\$150
(e)	If a person listed in paragraphs (b), (c) and (d) is being retested following a positive test result	\$150
(f)	If the test is being taken by any other person, in circumstances not listed in paragraphs (a) to (e).....	\$300

2. For the purposes of item 1—

- (a) a person is considered fully vaccinated fourteen days after receipt of the second dose in a 2-dose COVID-19 vaccine series;
- (b) a person is considered fully vaccinated fourteen days after receipt of one dose of a single-dose COVID-19 vaccine; and
- (c) a “**non-resident technician**” means a person who travels to Montserrat for the purpose of assisting with certification and maintenance of equipment.”

3. The following persons are exempted from the payment of the fee for a PCR COVID-19 test—

- (a) a person who is required to leave Montserrat on official Government business, provided that the person intends to return to Montserrat immediately after the completion of official Government business;
- (b) a person who is undertaking a course of study at an educational institution outside Montserrat, where the person is returning to the educational institution to undertake the course of study;
- (c) a person who, in the opinion of a health officer, is likely to be infected with COVID-19;

- (d)* a person who is referred overseas for medical treatment, where the person is proceeding overseas for the purpose of receiving the medical treatment;
- (e)* a person under 18 years of age;
- (f)* an official from an international or regional partner of the Government of Montserrat, who intends to visit Montserrat for official business;
- (g)* a person who resides in Montserrat and who is over 70 years of age; and
- (h)* a pilot who navigates a flight into Montserrat on a habitual basis.
